Borusan Mannesmann participated in the "Manavgat-Alanya-Gazipaşa-Anamur Districts Phase – 1 Natural Gas Pipeline Project Steel Pipe Procurement Tender" carried out by Boru Hatları ile Petrol Taşıma Anonim Şirketi (BOTAŞ) with the joint venture it formed together with Noksel Çelik Boru San. A.Ş. and Ümran Çelik Boru A.Ş. The aforementioned tender has been indisputably won by the Joint Venture for a consideration of TRY1,890,414,388 and a contract was signed with BOTAŞ.

Borusan Mannesmann's share in the tender amount will be TRY629,248,394.20. The delivery of the pipes in question will begin in the 3rd quarter of 2023 and will be completed in the 4th quarter of the same year.
